Dear Mr. Golden:


This office received your Request for Investigation on March 15, 2004. The allegations in your complaint are insufficient to warrant further proceedings by the Commission. Accordingly, this file is being closed.

The disciplinary system does not function as a monitor of pending litigation. If you have not done so already, you should bring your concerns to the attention of the trial judge. At this time, given the existence of your lawsuit and the nature of your claims, we decline to conduct an investigation of the matter.

Further, though we appreciate your sense of frustration, much of what you described is unfortunately inherent in litigation. We consider the trial court to be the first level of review for such issues in matters currently pending before it.
